Introduction

The annual release of selected official files continues against a background of greater public access through the Freedom of Information Act balanced against the need to protect personal information. The FOI Act (2000) created a new access to information regime and all records were reviewed in accordance with both that Act and the Data Protection Act.

Records continue to be brought forward for release as they approach 30 years of age. This involves the referral of the files to the Responsible Authority for sensitivity review. This entails a page by page examination to ensure that a record contains nothing sensitive as defined by the FOI Act and DP Act.

Records Recommended for Extended closure

A total of 8 NI departmental files were recommended for extended full closure. 54 NI departmental files were recommended for extended partial closure or contained information which has been blanked out to allow the release of the remaining contents of the file. In the majority of cases, the reason for extended closure was the section 40 Personal Information exemption of the Freedom of Information Act. This means that personal information is exempt from the right to know if it would cause a breach of the Data Protection principles.

A total of 7 NIO files were recommended for extended full closure. 66 NIO files were recommended for extended partial closure or contain information which has been blanked out to allow the release of the remaining contents of the file. In the majority of cases, the reason for extended closure was the section 40 Personal Information exemption of the Freedom of Information Act. This means that personal information is exempt from the right to know if it would cause a breach of the Data Protection principles.

Records Released

A total of 557 files are being released in full and 120 subject to partial closure or blanking out.

The topics covered by the files include: The 1981 'Hunger Strike' protests following the withdrawal of Special Category Status, political

negotiations on the constitution of NI, proposed NI Council as a form of devolved administration, Government assistance to Learfan and Shorts, Anglo-Irish economic cooperation, integrated education in NI and renewable energy exploration.
